1. Welcome, Regrets and Tom Longboat Acknowledgment

At 8:09 p.m., Jowenne called the meeting to order.

Jowenne presented the Tom Longboat acknowledgment:

As Longboat Roadrunners, we run to honour the spirit of Onondaga runner Tom Longboat; a member of the Six Nations of the Grand River, Canadian soldier, and Boston Marathon champion.

2. Approval of September 2020 Minutes

The Executive adopted the Minutes of the meeting held on Wednesday, September 23, 2020, amended to acknowledge that the 8- and 16-kilometer time trial event would also include a 10-mile course.

Motion to adopt minutes moved by George, seconded by Steve (Carried)

3. 8/16 km Time Trial (Final Details)

Steve gave an update of the event.

The course has been mapped out. Both races are almost full, with 18 and 16 people respectively.

Almost two full races: 18 and 16 people, with six Runners Shop runners in the 8 km, and the rest Longboaters.

Jojo shared images of the trophies he created for the winners.

Bert explained how to work the staggered start to calculate the times with the subtraction list.

4. Other Proposed Events (November 2020 – January 2021)

The members of the Executive Board discussed the 20 km time trial planned for the third week of November, revised from a possible half-marathon. Bert reminded members that the club maintains records for the 20 km distance.

5. Virtual AGM – Sunday December 6 11:00 a.m. -12:00 p.m.

The members of the Executive Board discussed the upcoming AGM, to be held virtually on December 6, 2020.

It was agreed that the meeting would be held over Zoom. George will talk to a club member who works for Zoom to ask if the club could get one-time access to the full version of the platform for the meeting. The members also discussed the possibility of purchasing a paid subscription. Jojo will inquire about rates for non-profit organizations.

The members discussed options for the format of the AGM, and that each board member should present a report. It was suggested that the objective should be to re-engage the membership, possibly by soliciting images for a slide show to show what's been happening with people over the past several months.

The Executive Board members indicated their interest in continuing to serve on the board.

- The Vice-president, the Treasurer, the Race Coordinator, and the Coaching Coordinator expressed an interest in continuing
- The Communications Coordinator and the Social Coordinator expressed a potential interest in continuing, pending some questions/reservations
- The Secretary indicated she will not be continuing

The members discussed how to vote in a virtual space, should there be a contested nomination. It was agreed that the polling feature in Zoom would be explored as an option.

It was agreed that a separate communications email would be sent, with a reminder about the AGM and nomination details and due date.

It was agreed that Executive Board members would each try to think of someone to nominate to the board.

6. Business Arising

Communications – the Members discussed the importance of communications as a good consolidation of club activities in socially distanced time. It was suggested to have a quarterly communications piece.

The next communications piece should be a reminder of the AGM and invitation to nominate or selfnominate candidates to the Executive Board and should be accompanied by the current list of members.

Uniforms – Jojo gave an update on the uniforms. The club's choices are available in sufficient quantities (at least 30 per size) with the exception of the "magnet" pullover, which has been discontinued. Instead, an athletic zip with garnet stripe will be offered.
