2) Constitutional Amendments (Rob Hanks)

Constitutional Amendment One:

Whereas the Longboat Roadrunners were named in honour of Tom Longboat, BIRT the following sentence be added to Section 4 "Objectives" as Clause 4-1-a (and that all other clauses in that section be accordingly re-alphabetized). The objectives of the club are ... "To honour the legacy of Tom Longboat." Passed unanimously.

Constitutional Amendment Two:

Whereas communications in the age of email and social media have become too complex and voluminous, BIRT clause 9-4-b ("That the club secretary shall keep a book of ... all club correspondence") be deleted from the constitution because it is unrealistic and unworkable (and that all other clauses in that section be accordingly re-alphabetized). Passed unanimously.

Constitutional Amendment Three:

BIRT the following sentence be added to Section 6-1 as Clause 6-1-a:

"Further, all Officers of the Board shall endeavour to archive all correspondence which they conduct pertaining to club business." Passed 35 to 11.

Constitutional Amendment Four (2nd edition):

Whereas the terms "Discipline" and "Disciplinary" are unduly harsh and create a negative impression about the club, BIRT:

1) clause 1-d ("Membership Review Committee means Standing Committee on Discipline.") be deleted, and that all other clauses in Section 1 be re-alphabetized accordingly;

2) that all remaining references to the "Standing Committee on Discipline" be changed to the "Membership Review Committee";

3) and that all references to the "Disciplinary Committee" be changed to the "Membership Review Committee." Passed.

Constitutional Amendment Five:

Constitutional Clause 5-5-b currently reads as: "Club members are required to ... assist with the organization of two Club fund-raising events in each membership year."

Whereas club practice only emphasizes mandatory duty for the Longboat Toronto Island Run, and whereas the Toronto Island Run is the a major source of club revenue, and whereas some club members do not perform this duty, BIRT Clause 5-5-b be changed to the following:

"Club members are required to ... assist with the organization of no *fewer* than one Club fund-raising event in each membership year, and that if they do not fulfill this function, they must make a suitable compensatory contribution to the club."

Proposed amendment "to be negotiated with the Membership Review Committee." Passed 31 to 16.

Main motion passed unanimously.

Working text:

In addition to these formal constitutional amendments, the Constitutional Committee would like to present the following working text for comments:

"The club President, or a designated representative, shall make a statement honouring the heritage of Indigenous peoples prior to the AGM, Membership Meetings, club races, and any sanctioned club event. This statement shall be considered a living document subject to revision and review."

(Our thinking is that a clause like this would go into the constitution, but that the actual statement honouring Indigenous Peoples would not so that it could be more easily adapted to reflect changing social and cultural conditions. We believe that this statement should be ultimately approved by the members and could be attached as an appendix to the constitution. We also believe that this statement should be made in consultation with representatives of the Longboat family and Indigenous communities.)

Richard Bailey commented that a Wednesday night run is considered a sanctioned run for insurance purposes. A list of events would be helpful.
