Longboat Roadrunners Executive Meeting Minutes – Approved

1. Welcome, Regrets & Tom Longboat Acknowledgement (Jojo)

At roughly 8:00 p.m., Jojo called the meeting to order.

Jojo presented the Tom Longboat acknowledgment

As Longboat Roadrunners, we run to honor the spirit of Onondaga runner Tom Longboat; a member of the Six Nations of the Grand River, Canadian soldier, and Boston Marathon champion

2. Approval of Prior Minutes (Paul)

3. Club Activities Updates

Membership & Recruitment Update (Paul / Jojo / Kat)

- Currently at 69 members for 2022 with 29 females / 40 males and 14 coached members
- Three current members have renewed at the early bird renewal price.
- Recruitment efforts continue as we build upon the new club shirts, QR codes @ Sunset Shuffle and social media promotion
- Follow-up email was sent to the 600+ participants consisting of a thanks, top results, apology related to special award comments, event photos, club information and new member / family member pricing.

Cheer Station with TRS (Susan)

- Longboat was invited to participate in a cheer station with The Runner Shop at the 2.5km mark of the TCS Waterfront Marathon
- There will be 22 cheer stations competing with a judges group going around the course
- We will have our own Longboat flag with club members wearing club clothing (to promote our club brand) goal is to be fun, supportive and loud
- Susan will be reaching out to members via Facebook and direct contact. Given the early race position it should only be an hour commitment for members to join.

2022 X-Country Championships (Bert)

- Successful event with good attendance by runners and volunteers this was the first championship in 3 years and was followed by a social at Cranberries.
- Club champion will be announced at the AGM as Steve given that the fastest runner is not a club member.
- So ... Steve was the Overall Club Champion and Mary Liu was the Female Champion.

40th Island Run Outcomes (George)

Introductory thoughts from Jojo (earlier in the meeting but captured here)

- Large participation of indigenous runners spanning different treaty groups
- Coverage from CBC for their programming on National Truth and Reconciliation Day
- Good both to raise awareness of the indigenous community and to promote Longboat
- Also noted that we should issue a club statement on National Truth and Reconciliation Day
- Special thanks to George for his leadership as Race Director

Summary from George:

- Strong participation with 1,627 people signed up including
 - o 770 entrants for the 10K with 656 finishers (85%)
 - o 575 entrants for the 5K with 499 finishers (87%)
 - o 151 entrants for the Kids 1 Mile with 116 finishers (77%)
 - o 131 entrants for the Kids Fun Run
- This year was "block registration" with price increases as blocks are consumed (vs our past approach with calendar-based increases). As a result, revenue for 2022 was \$78,555 vs revenue of \$75,527 in 2019 when we had 114 more people registered so a big win.
- Early estimate on the financials is roughly \$23K generated for the club (post expenses) although Bill is still working to close the race financials.

- Race Roster lets us use promo codes and we offered 21 codes to various run clubs and indigenous groups and 88 people took advantage of our offers.
- Our charitable partners had a successful fundraising from a combination of donations via Race Roster, New Balance and the Runners Shop:
 - o School Box North raised \$5,283
 - o Native Canadian Center of Toronto (NCCT) raised \$2,756
- New Balance and Runners Shop both seem quite happy from our partnerships.
- IMAGICA photo booth was also well received with 250+ people / groups using the booth. Unexpectedly people received a physical photo as well which included "Longboat" and "40th Anniversary Run". And Longboat has approval to use these 250+ images on our social media to promote the club.
- Team captains will be providing feedback that George will circulate later.
- Informal feedback from participants has been very positive.

Fall / Winter Programming and Early 2023 – Awards Gala (Jojo)

- Initial discussion of fall / winter programing ideas such as a longer 20km club race or a shorter event to encourage runners to recover in the off season (e.g. adventure race, scavenger hunt, time trial etc.)
- Discussion shifted to the Annual General Meeting since a running event could be connected to the AGM. Consequently, the location will have an impact on the style of event ...
- There was consensus to (1) organize a hybrid AGM event as many people are still not comfortable meeting indoors for large gatherings, and (2) target in November to avoid disrupting the popular December challenge event.
- George will organize a scavenger hunt if that running option is chosen.
- Stephen will start calling potential venues ...
- Technology for the hybrid meeting was recognized as important to give everybody an engaging experience consideration is needed for a wide frame camera, large screen television, internet connections etc.
- Potentially we could use a party room at a member's condominium depending upon the number of people attending in person. Technical logistics may be easier and often condominiums have showers / change rooms for post run (Kat & Steve to investigate).
- Jojo asked that we follow-up next meeting (1) whether to have a standalone running event or schedule with the AGM, (2) what type of running event and (3) potential venues including IT technology.
- Initial discussion about the Awards Ceremony

- Venue options could include Royal Military Club that we've used in past years, the University Club where Jojo has connections etc.
- Expectation is that the Awards Ceremony will be hybrid so the AGM will be a good test for the technical logistics.
- Further discussion planned for our October / November meetings.

4. 2022 – 2023 Strategic Planning - Ongoing (Susan / All)

Membership, Visibility, Programming/Events

- Plan to continue strategic planning and touch on visibility / programming while continuing the membership drive
- It was noted that as we expand family memberships, we should start considering family-friendly races to attract more people.
- Next meeting for the strategic committee was decided as Wednesday November 9.

5. Financials Update (Bill)

- Sept 30 financials were circulated and are attached.
- Bill is targeting to finish accounting for Sunset Shuffle and Island Run in early October (eg. charity payments, prizes etc.)

6. Other Business (Jojo)

• Jojo confirmed that we continue to reimburse the race fees of members who run as part of a Longboat team (up to \$30).

7. Adjournment (Jojo)

Jojo adjourned the meeting at approximately 9:10pm
