December Challenge Outcomes (All)

- This is the 3rd year for the event so it's becoming a key part of Longboat programming

 George actually posted on Facebook earlier "… we raised \$700 for Second Harvest Food Bank - which will be matched \$ for \$ by Longboat. Even better, the total amount (\$1400) will be matched by one of Second Harvest's regular donors, to make a total contribution of \$2800 … this amount will provide 5600 meals for those most in need."

January 5K TT & Winter Programming (All)

- Encouraging club members to join a Park Run event as the January 5K time trial.
- Anticipate 10 members joining based on Facebook interest typical for past TT events.
- Bert reminded us that participants need to register on Park Run website beforehand.
- Further discussion needed about club race(s) this winter / spring given the resurgence of races including Chilly, ATB, Boston and Toronto.
- Goal is to continue with the Longboat Connects series (originally introduced during Covid-19) potentially with a hybrid yoga event led be Tanya Johnson.
- Bert suggested we relaunch the new members brunch that has been "on hold" during Covid-19 – the brunch traditionally includes a relay event with several course options available including High Park or the Dominion Pub neighborhood. Steve, George and Bert to work out the details for a potential March event.
